(For Admission Through Merit Based on Marks Obtained in 10+2 Examination)

APPLICATION FORM FOR 10+2 MERIT BASED ADMISSION

This application form is for admission to B.Tech. Branches at JUET Guna (M.P.) only. These admissions will take place independent of JEE based counseling/admission.

THREE STEP PROCESS

- Step-1 Fill JUET Admission Form and send it to the address given at S. No. 2. Applicants are advised not to wait for declaration of results.
- Step-2 Counseling 'On Line' or 'In Person' – **To be Notified Later.**
- Step-3 Registration - **To be Notified Later.**

GENERAL INSTRUCTIONS

Please carefully note the followings before filling the application form/ applying online.

- (i) The candidate should have minimum of 60% aggregate marks in the 10+2 or its equivalent examination with **Physics and Mathematics as compulsory subjects** and one out of ; Chemistry, Computer Sciences, Informatics Practices, Multimedia & Web Technology, Engineering Drawing, Engineering Graphics, Information Technology, Technical Vocational Subject, Agriculture, Business Studies and English.
- (ii) While filling the application form applicant must mention roll number and name of Board of Examination. School No. & Center No. is mandatory for those who choose "CBSE" in 10+2 board. Other fields can be left blank by 2020 Class XII students. 2018 & 2019 pass out candidates should fill all the fields. Applicants are advised not to wait for declaration of 10+2 result for submission of application form.
- (iii) Merely filling an application form does not entitle the candidate for admission or call for counseling. The candidates fulfilling the requirements will be called for counseling.

BRANCHES AND SEATS ON OFFER

The tentative number of seats for Academic Session 2020-21 for 10+2 Merit Based admission is given in the table below:-

1. How to Obtain and Fill the Application Form

The students may fill the application form in any of the following ways:-

(a) Apply Online

Apply online on website <https://www.getadmissions.com/jaypee> and follow the instructions given there.

- (b) Download Application Form from <https://admission.juet.ac.in/static/2020/BTPT20.pdf>. Do not forget to attach a DD of Rs. 1200/- in favour of **Jaypee Admissions Account, payable at Noida/Delhi** while sending it to the address given at Para No. 2.

Or,

Obtain Application Form and brochure on cash payment of **Rs. 1200/-** from university and send completed application form to the address given below at Para No. 2.

Candidates who have already paid application fees for JEE based application form need not to pay the application fee again.

3. **IMPORTANT TO NOTE BEFORE SUBMISSION OF APPLICATION FORM**

- * **Last Date of Application:-** Ensure that the completed Application Form reaches on or before **19th July 2020**.
- * **Display of Application Status:-** Candidates shall generally be able to see the receipt details of their application forms and essential data on the website within 15 days of application or immediately after the last date of submission of application.
- * Candidates are also advised to keep the original receipt of the Speed Post/Registered Post/Courier and the photocopy of the filled in Application Form. In any case all issues regarding non receipt of form must be resolved before declaration of merit.

MERIT LIST, COUNSELING AND ALLOCATION OF SEATS

4. **Criteria of Year of Qualifying Examination**

Candidates who passed 10+2 Examination between 2018 and 2020 are eligible for the admission.

5. **Eligibility for Merit** - Candidates shall be considered for merit process once they meet all the following criteria:-

- * Who apply in the prescribed application form.
- * The applications are received before the due date, complete in all respects.
- * Who fulfills the eligibility criteria.

6. **Drawing the Merit List:-**

- * Merit shall be drawn as per General Instructions (i).
- * All candidates having same percentage of marks in 10+2 Examination Merit shall have same opportunity for selection of branch.
- * The University complies with reservation policy of the Government of MP.

7. **Invitation for Counseling**

Invitation for counseling shall be sent /available through following ways:-

- * Candidates shall be informed through E-mails & SMS. Thus, candidate must mention E-mail address and mobile numbers correctly while filling the application form.

8. **Counseling**

- * JUET, Guna shall hold counseling Online/In Person (**Date To be Notified Later**). Candidates must monitor and view the website for details without fail.

- * Merit list candidates, who are called for counseling, must go through counseling/admission instructions mentioned in counseling letter carefully regarding filling up of choice of branches. Ignorance of laid down instructions shall be the responsibility of candidate.
- * **Seat allocation will be made in order of merit and choice of branches filled by the applicant in the application form. In case any requirement for change of priority for branch, applicants are advised to write a mail on e-mail id- counselling@juet.ac.in latest by 19th July 2020 (4PM), mentioning 10+2 Roll number, Name of Applicant, Date of Birth and revised Choice of Branches.**
- * Candidates shall be allowed to exercise choice for all branches of engineering at JUET Guna. Thus the candidate shall have the option of up gradation in branches as per the Merit and Priority exercised. The candidate shall have the option of freezing the admission, if so desired, any time before next updation is carried out as per the schedule to be announced with the counseling instructions.

9. Allocation of Seats

- * Seats in the study branches shall be allotted on the basis of preferences indicated in the application form, strictly in order of merit.

10. Reservation of Seats

- * The University complies with reservation policy of the Government of MP.
- * 10% seats are reserved for wards of serving and retired Armed Forces and Paramilitary Forces Personnel. 30% concession in Tuition & Development Fees for wards of serving and retired Armed Forces and Paramilitary Forces Personnel will be provided. Additional 5% concession (i.e. 35%) in Tuition & Development Fee will be provided for wards of War Widows and personnel killed in action. This concession will be subject to verification of original documents.
- * Reservation / Concession are available for wards of Kashmiri Migrants / Kashmiri Pandits / Kashmiri Hindu Families (Non-Migrants) living in Kashmir valley as per MoHRD D.O. No. 1-13/2010(CPP-II) dated February 26, 2020.
- * **All vacant seats are inter-transferable in either category i.e JEE(Main) to 10+2 marks Merit basis and vice-versa.**

11. Important Dates

12. General Instructions on Conditions of Eligibility

- * Candidates must produce certificates of proof of the above conditions at the time of registration.
- * If a candidate is found ineligible even at a later date after admission to the University, his/her admission will stand cancelled. All admissions will be subject to verification of facts from the original certificates/ documents of the candidates. The decision of the Admissions Committee of the University regarding the eligibility of any applicant shall be final.

- Tuition & Development Fee, once fixed, will remain same for total duration of study. Hostel charges may be revised by the management from time to time.
- For NRI Category Tuition fee is 4000 USD, Development Fee is 1000 USD and Hostel fee is 2000 USD per year.

14. Candidates are required to ensure that the completed application (or printout of online form) along with demand draft (if not paid online) is received before the last date.
15. **Ragging is banned in the University. Any student indulging in ragging shall be liable for disciplinary action; including expulsion from the University.**

17. **Important: Please note that Inter university transfer of students is not permitted.**
